Noted: That the Union's Interim CEO had conducted an informal survey with

CEOs from other Universities and had come up with a list of possible candidates. It was agreed that support from the University Finance department on the process would be helpful, and that to aim to have the process completed by November 2019 was a realistic timescale, if the invitations to tender were sent out week beginning 16 September.

A shortlist of three auditors was anticipated.

To this end it was agreed that the Union and PVC and Director of Finance would discuss the matter further outside of the committee.

could be negotiated (the Union had spoken to the consultants recommended in the Greenhouse report). It was suggested that a consultant may not be necessary to recruit all four trustees.
